## General Minutes

## Description

- **Welcome and apologies:** JH welcomed everyone present to the meeting and confirmed DC was an apology, no other apologies were received.
- **Confirm minutes of the last AGM:** The 2022 AGM minutes were distributed to all members to read prior to the 2023 AGM. JH summarised the minutes and asked for any questions or feedback, and no one present had any. KL called a motion to accept the 2022 AGM minutes, DP seconded, and the minutes were unanimously accepted by all members present.
- **Treasurers Report:** KL stepped through the 2022/2023 Treasurers report, speaking towards the profit and loss for the last financial year. Highlights were that we were in surplus of \$2783.69. KL spoke about our sponsors, who they are, when we received money from them, and how much. KL also spoke about how our sponsorship and grant money is spent, see report below. AS asked whether we were continuing our partnership with Performance and if the Metro team are still receiving strength and conditioning training. JH confirmed the committee decided that there was not enough buy in from the metro team to justify the cost. JH called a motion to accept the Treasurers report, MH seconded, and the members present unanimously agreed.
- **Presidents Report:** JH summarised the presidents report thanking all the committee members, club officials, and management team. JH spoke about the last 12 months achievements and goals. The Women's World Cup and Morten Bay Pride festival were discussed as opportunities to increase awareness of the club and achieve strategic goals such as registering a women's team for Metro league 2024. The full report is available below. MH called a motion to accept the Presidents report, DL seconded, and the members present unanimously agreed.
- **Special Resolutions:** There were no special resolutions presented to the club members.
- **Elect Officer Bearers:** JH confirmed the committee was now dissolved and handed the chair to Daniel Lord, elect officer bearer who declared that all office bearer and general committee members of the Brisbane Inferno FC Committee are vacated.
  - DL declared there were zero (0) valid nomination forms received for the role of president, and so opened it up to the floor. Adele Stirling nominated Jacob Hendrie, there were no further nominations, Kirsten Lawlor seconded the nomination, and the members present unanimously agreed.
  - DL confirmed there were zero (0) valid nomination forms received for committee positions and so opened it up to the floor.
    - i. Adele Stirling nominated Kirsten Lawlor for the Treasurer role, there were no further nominations, Daniel Puselj seconded, and the members present unanimously agreed.
    - ii. Alan Michael nominated Michael Healey for the secretary role, there were no further nominations, Daniel Puselj seconded, and the members present unanimously agreed.
- **General Business:** KL stated that Brisbane Inferno FC was now classed as a level 2 incorporated association, due to the annual turnover, and called a motion to appoint a person and accept the associated costs, to conduct an audit on the financials presented at the 2023 AGM, David Msiki seconded, and the members present unanimously agreed.
- **PFA representative:** DL spoke about what Pride Football Australia (PFA) is, what they do and what they are trying to achieve. MH confirmed that he had volunteered as the club and community officer for the PFA committee, representing BIFC on the PFA committee.
- **AOB**
  - **Gay Games, Hong Kong 2023:** MH asked for everyone present for a show of hands on who would be interested in attending the Gay Games in Hong Kong, November 2023.
  - Daniel Puselj asked if there was any work being done to connect with other LGBTQI+ sports clubs in Brisbane and Queensland. JH confirmed whilst we have some connections with the Hustlers, more can be done and asked Michael to add this as an agenda item for the next committee meeting.

JH called the meeting close.
